

## Checklist for Change of Domicile From New York State to Domicile State

- 1. File a Domicile State Declaration of Domicile in the local County Clerk's Office, if applicable.
- 2. Pay Domicile State Tangible property taxes, if applicable.
- 3. File for Domicile State homestead exemption, if available.
- 4. File a nonresident New York income tax return, if required.
- 5. File the federal income tax with the proper IRS Center in Atlanta, Georgia.
- Transfer safe deposit box contents and bank accounts to Domicile State. Have your Social Security check directly deposited into a Domicile State bank or mailed to your Domicile State address.
- 7. Close any bank accounts and/or securities brokerage accounts in your former state.
- 8. Change credit cards to Domicile State address.
- 9. Execute a new Domicile State Will (claiming Domicile State as domicile and taxing jurisdiction).
- 10. Refer to Domicile State residence in all deeds, contracts and other legal documents.
- 11. Where feasible, have family gatherings and social activities centered in Domicile State rather than in New York.
- 12. Change the address on your passport to a Domicile State address.
- 13. If you intend to invest in real estate or businesses, you should focus on those located in the Domicile State area rather than those located in the New York area.
- 14. Transfer works of art, expensive furniture, heirlooms and sentimental items to Domicile State.

- 15. Consider acquiring cemetery plots in Domicile State and make any funeral arrangement through a Domicile State funeral director.
- 16. Register your automobile in Domicile State.
- 17. Obtain a Domicile State resident driver license.
- 18. Register to vote in Domicile State.
- 19. Sell New York residence and purchase a residence in Domicile State or enter into a lease for rental for as long a term as practical.
- 20. Go to the Post Office. Get two copies of their change of address forms. Submit one copy, and have the other one notarized. Keep it to show the date.
- 21. Notify banks, brokers, attorneys, accountants, creditors, insurance companies of your new Domicile State address.
- 22. Establish charge accounts with Domicile State stores.
- 23. Use the Domicile State address when registering in hotels, etc.
- 24. Join Domicile State clubs, societies, fraternal organizations, temple or church; become a patron of local activities (symphony, theatre, etc.); and participate in charitable activities, fund raising for community affairs, etc. Resign from all New York social clubs or change your membership status in such clubs to "nonresident."
- 25. Stop contributing to charities and political candidates in your old state, and tell them why. Auditors look at contributions closely.
- 26. Cultivate several relationships in Domicile State so you actually "feel" that you are part of the community and it is your home.
- 27. Get a Domicile State doctor and dentist and have all New York medical records forwarded to your new doctor and dentist.
- 28. Do not spend more than 182 days in New York State after you have changed your domicile to Domicile State.
